  - a. Approximately \$285,000 in pledges are yet to be fulfilled for 2023. The budget deficit of \$118,839 as of 11/30/23 plus projected expenses for December are expected to be covered by receipts in December.
  - b. An Employee Retention Tax Credit is expected to offset some payroll tax expenses. More details on the timing and amount will follow.
  - c. YTD expenses are below YTD budget expectations.
  - d. Total cash: \$960,628
  - e. Mortgage Balance: \$1,622,989
  - f. A copy of the financial statement is available upon request to members in the church office.
- III. Budget Discussion: Missy Radigan
  - a. Missy presented a budget proposal with updates made since the previous meeting.
  - b. Kate Patrick made a motion to approve the budget proposal. The motion received a second and carried unanimously. It will be presented to the congregation at the Annual Meeting.
- IV. Update on Staffing: Pr. Tim Selbo
  - a. Preschool needs part-time aid position has been filled by two parents sharing the role
  - b. The part-time custodial position has been filled by Joe Schwebach.
  - c. CYF position is close to being finalized.
  - d. Discipleship Coordinator Position will be coming available at the end of this year. There is a candidate for the position.
  - e. Personnel Policy- Council discussed making changes to the personnel policy manual over the next year. Further discussion will take place at the January meeting.
